Proposal--Include the correct wording of the proposed resolution< br>Code of Ethics (originally adapted from the American Forensics Association Code of Forensics Program and Forensics Tournament Standards for College and Universities)

1. Phi Rho Pi (PRP) is committed to promoting professional communication conduct. The members of PRP recognize the adversarial and competitive nature of academic debate and individual events may place students, directors, coaches, judges, and tournament administrators in situations where professional conduct by participants may be called into question.
2. The explicit focus of this policy addresses conduct by participants outside the specific time period when a student is competing in a round during a tournament. Participants include audience members, students, directors, coaches, judges, and tournament officials.
3. PRP acknowledges the district and national tournaments sponsored by the association are designed to promote responsible and effective discourse. PRP recognizes that behaviors which belittle, degrade, demean, or otherwise dehumanize others are not in the best interest of the activities sponsored by PRP. Such behaviors interfere with the goals of forensic education.
4. All participants in a PRP sponsored event shall recognize the rights of others and communicate with respect for opponents, colleagues, critics, tournament hosts and audience members. Behaviors by any tournament participants occurring at a PRP sponsored event that violate the community standard of a healthy educational environment shall be deemed "Unprofessional Conduct." Unprofessional conduct is subject to sanction(s) by PRP.
5. Forensics educators shall act in accordance with their own institutional obligations. Failure to adhere to employer's policies (e.g., a person suspended or terminated for violations of university sexual harassment policy, substance abuse policy, fiduciary policy or academic responsibility policy may be subject to sanctions by PRP).
6. A charge of unprofessional conduct may be reported to PRP Ethics Committee or to a member of the PRP Executive Board.

Provide rationale FOR the resolution

In the past, PRP has used AFA's code of ethics. However, the AFA code of ethics now includes rules and regulations that either do not apply to PRP or negate the rules of PRP. As a result, we need to create our own Code of Ethics to place on the PRP web page.

The Code of Ethics listed here has been adapted from the old AFA Code of Ethics.
