A. Recording Secretary – John Nash

- 3. Explained that we reduced fees for the tournament this year. Due to extra income from last year. We may go in the red this year, but that was planned due to the reduces fees.

E. Comptroller - Cynthia Dewar

- 1. Reported that our current bank no longer wants to hold our account. The Trust is being terminated. This is a good outcome. We hired a lawyer to help us terminate the original trust. Half the funds were moved into a trust we cannot touch. The other half went into a trust that will earn money for the organization. We should earn between \$5,000 and \$10,000 each year for membership. We also need to hire another lawyer to help us with the new trust.

 - b. M'Liss Hindman spoke about AFA-NIET elected its first community college officer. AFA is also considering bringing IPDA as an event. AFA is talking about labeling 'trigger' topics. AFA is also talking about adding a sexual harassment committee and a diversity committee. POI has moved flights at AFA. AFA will continue to let University of Alabama still host AFA.

C. Site Selection – Jolinda Ramsey

- 1. Proposal #1 (Page 6 of packet) The bid for the Phi Rho Pi National Tournament to be held in Albuquerque, NM at the Crowne Plaza for April 6-11, 2020 was recommended by committee. Hosted by Region IV. MSP
- 2. Proposal #2 (Page 7 of packet) The committee accepts the bid for the Phi Rho Pi National Tournament to be held in Minneapolis, MN at the Hyatt Regency for April 5-10, 2021 pending site visit and contract review. No host has been identified yet. Motion to postpone this proposal to a later date once we have a contract and cite visit. Most likely next Phi Rho Pi business meeting.

E. Ethics - Lauren Morgan

1. We are not federally funded so we do not have to have a Title IX policy. However, we would still like to work toward getting a policy in place to help maintain our ethics. The committee will pass on to the executive board their findings.

1. The committee met and decided that the constitution needs revision. Some of the constitution is outdated and has some language that is not gender neutral.

H. Interpretation - Kevin Briancesco

- 1. Proposal #1: (Page 8 of packet) Committee did not recommend this proposal. It dealt with the idea of eliminating Prose and Drama and replacing it with "single-voice interpretation" and "multi-voice interpretation."
- 2. Proposal #2 (Page 9 of packet) Proposal for a 1 year trial in Dramatic Interpretation where the use of a manuscript during performance will be optional. Discussion began both for and against the proposal. MSP
- 3. Proposal #3 (Page 10 of packet) Proposal for a 1 year trial basis to move Poetry Interpretation from Pattern B to Pattern A and move Communication Analysis from A to Pattern B. Discussion began both for and against the proposal. This proposal was pushed to the rules committee for next year.
- 4. Proposal #4 (Page 11 of packet) Change Section 3 11 B 4 h ii from "Contestants may not change the text's narrative point of view or sex of a character." to "Contestants may not change the text's narrative point of view." Discussion began both for and against the proposal. MSP committee will continue the discussion to help clear up language.
